For good and valuable consideration, the receipt of which is hereby acknowledged, I hereby irrevocably sell, assign, and transfer to Company all of my interest in the copyrights in the photograph or audio-visual work in which my Likeness appears (hereinafter the "Copyrights") including but not limited to the worldwide copyright, together with all rights to secure copyright, renewals, reissues, extensions of the copyright, all accrued causes of action for past and present copyright infringements, and all rights to chooses of action for past and present accrued damages. I represent and warrant that I am the owner of the Copyrights and have the right to make the grant herein, and that I agree to indemnify, defend, and hold harmless Company from and against any and all claims, liabilities, damages, costs or expenses including, without limitation, reasonable attorney's fees and costs, arising out of or in connection with this representation and warranty. In consideration of the substantial expense undertaken by Company and reliance upon my permission hereunder, I agree not to assert claims of any nature whatsoever against anyone relation to Company's exercise of the rights granted hereunder.
